2.	The Borrower is also responsible for the care of all non-instrument materials of the Instrument Petting Zoo including tablecloths, poste etc. These items are to remain in the borrower's possession until the termination of the rental.							
3.	The Borrower is responsible for all instrument, associated accessory and non-instrument material repairs or replacements required due to loss, damage or destruction while items are in The Borrower's possession.							
4.	The Borrower is responsible for paying the Fifty Dollar (\$50.00) required rental fee to the Winston-Salem Symphony on or before the agreed upon Zoo pick up date. Additionally, The Borrower may be required to complete a brief instrument petting zoo training session the additional cost of \$15. The Zoo can also be delivered to your location for the additional transportation fee to be determined based time and distance.

The Winston-Salem Symphony reserves the right to terminate the rental agreement at any time and for any reason, and if such agreement is terminated, The Borrower agrees to return all Instrument Petting Zoo items within 24 hours and the Symphony will return The Borrower's payment, exempting any fees for services already rendered.							
6.	. Winston-Salem Symphony must be notified of any cancellation at least seven (7) calendar days before the planned rental. If a cancellation occurs after this deadline, The Borrower will be responsible for payment in full.

#### Instrument Petting Zoo Rental Agreement

## Rules and Regulations for Use

- 1. The Borrower agrees to take the utmost care to protect the instrument(s), associated accessories and non-instrument materials in the prevention of loss, theft or damage. In the unlikely event that an instrument or other item is damaged, the Winston-Salem Symphony must be notified immediately.
- 2. The Borrower is not authorized to lend any instrument or associated item to a second party.
- 3. The instrument(s) and associated items are to be used only for educational purposes unless permission for alternate use has been granted by WSS in advance and in writing.
- 4. The instrument(s) and associated items are not to be used in conducting private instruction or in any other for-profit endeavor.
- 5. If the instrument(s) and associated items are used in a recording or during a public performance, The Borrower must acknowledge WSS as the owner and provider.
- 6. Any damaged instrument(s) or associated materials are not to be taken to a repair person or luthier without first obtaining the written approval of the WSS.
- 7. The instrument(s) and associated materials shall not be subject to extreme cold or hot temperatures, or to exposure to the elements. Temperatures between 60-80 degrees is ideal. If presenting the Zoo outdoors, the instruments must remain in a covered area. The instrument(s) and associated materials are to be stored in closed cases in a well-regulated environment when not in use.
